2019 TRIPLE R SEASONAL SITE LICENSE

(Non Resident)

Seasonal Camper Cash or Check Discounted Site Fee: \$2,450.00

A Triple R Seasonal camper is a camper that is typically camping on weekends with the occasional 3 or 4 day weekend and a weeks' vacation or two during the summer. They do not live at Triple R Monday - Thursday week in and week out.

A \$400 cash or check, **NON-REFUNDABLE**, deposit is due on or before Monday, September 3rd, 2018 or upon signing of site license for a new seasonal. **Deposits will not be accepted without a signed license.** The balance is due, in full via cash or check, on or before opening day of the camping season or upon a new seasonal moving their camper on site. If paying via credit card, there will be a 3% credit card adder. **Rig must be 10 years old or newer** for all new seasonals.

Seasonal campers are invoiced for their electric usage; June 15, August 15, & October 15. Invoices will be emailed or can be picked up in the office. Payment is due upon receipt of invoice. Past due at the end of the month. Past due accounts will result in late fees.

The Seasonal Site License covers a family of 5 → **The Licensee, the spouse/partner and 3 of their unmarried children, 21 & under, all living at home together.** The parents of the licensee and spouse/partner are free to visit during the day, but not over night.
